*Applicants for playground positions must have completed 8th grade. \$35 fee required.

Playground sites: Nassau, Dunham-Lebed, Inman and **Williams Park and Franklin Park School (**extended day).

Activities run from June 28th through July 30th. This service program provides teenagers, who have completed 7th grade (8th grade for playgrounds), with the opportunity to gain valuable experience as a volunteer member of the Franklin Township Recreation staff. Participants may contribute their time and energy to receive important hands-on training in caring for children. This program is designed to promote community service and to teach and enhance work skills but does not guarantee future employment with the Recreation Department. C.I.T.'s will: assist staff in planned activities, preparation and clean-up; provide 1-to-1 assistance to program participants; and lead activities under staff direction.

1. Pre-registration is required and applications must be received by June 4, 2010. C.I.T. participation is limited and placement is dictated by enrollment and the ages of the participants at the site requested.
2. A current report card and one (1) letter or recommendation (not from a family member!) must accompany your application.
3. For playground C.I.T.'s a registration fee of \$35 must accompany your application. If you plan on attending, trip fees must be paid by the due dates posted on the playground calendar.
4. C.I.T.'s are required to sign a contract stating they will: attend an orientation session, be present for 90% of the program (with a max of 3 excused absences and no unexcused absences!), conduct themselves in an appropriate manner, and follow the directions of their supervisors.
5. Returning C.I.T.'s must have favorable recommendations.
6. All C.I.T.'s successfully completing the program will receive a certificate and a token of appreciation.
